On or around the week of 18 September 2018, the Panel will select one (1) nominated Maintenance Hero as the Maintenance Hero Grand Prize Winner (the "Grand Prize Winner") and two (2) Maintenance

Hero Runners Up Prize Winners (the "Runners Up" and collectively with the Grand Prize Winner, the "Potential Winners" and each a "Potential Winner"), based on the Judging Criteria. Sponsor will contact each Potential Winner, and confirm each Potential Winner's compliance with these Official Rules and consent to participate in the Contest. All decisions of the Panel are final.
